Hi again -- Have been going back and forth with my editors about this. They're essentially saying, if we want to do a deeper dive into UDF and talk about why they're a "Ponzi-like" scheme at this point, this has to be on the record at least somewhat.

My editors do have a good point -- it's been widely reported that you're rumored to be involved, and UDF's statement makes clear that they've connected the dots. So from a safety perspective, we wouldn't be telling them anything they didn't know (or strongly suspect).

I'm thinking -- if you did want to remain at arm's length a bit -- simply confirming that you guys are the source of the posts but not commenting further would be enough for us to do a deeper dive into the points you bring up. I think it would give me enough of a hook to write a thorough story.

I know that's probably not the answer that you're looking for. I think it's important to have a story on the broader issue and probable bad behavior by UDF, but unfortunately I'm limited in how I can approach this.
