ORDER

3. Plaintiffs' Motion to Compel Re Subpoena to Daniel J. Edelman, Inc. is GRANTED.

IT IS FURTHER ORDERED that third-party Daniel J. Edelman shall fully respond to and produce all documents responsive to Plaintiffs' Document Request Nos. 1-18.
