This move would also be a risk on the part of UDF because it would invite more media attention and market scrutiny.

More broadly, we'll want to quickly evaluate whatever disclosures and accompanying exhibits are shared before incorporating a response into a likely media blitz. The local media and advisor outlets, in particular, will still be workable targets. We'll also want activate digital (e.g. perhaps still) and paid amplification of the microsite quickly.
