DECLARATION OF BARRETT HOWELL IN SUPPORT OF REPLY TO GOVERNMENT'S RESPONSE TO MOVANTS MOTION FOR RETURN OF PROPERTY PURSUANT TO RULE 41(G)

I, Barrett Howell, hereby declare as follows:

1. I am a partner at the law firm Katten LLP, and I have represented United

Development Funding ("UDF") since 2012. I am a member in good standing of the State Bar of

Texas.

2. On the morning of February 18, 2016, local news and live-feed broadcasters began

congregating outside of UDF's corporate headquarters in Grapevine, Texas. Next, approximately

two hundred FBI and other federal agents executed a search warrant of UDF's corporate

headquarters. Live, real-time coverage of the raid created chaos and confusion in the market,

particularly the market for UDF IV's publicly traded securities. NASDAQ therefore halted trading

in UDF IV's shares due to the panic and pandemonium instigated among UDF's investors. The

trading halt further frustrated UDF's investors' ability to trade their shares, and also complicated

UDF's ability to conduct its residential real estate finance business and its search for and ability to

retain an independent auditing firm.

3. In March of 2016, more than four weeks after the search warrant was executed at

UDF's corporate headquarters, we began requesting of Prosecution Team Lead AUSA Nick

Bunch, with due urgency, that the government provide UDF access to the physical materials seized

from UDF on February 18, 2016. We explained to Prosecution Team Lead AUSA Nick Bunch

that UDF required access to the materials to operate its business, comply with its financial

reporting requirements, and retain a new auditor.

4. I discussed with Prosecution Team Lead AUSA Bunch the increased expediency

with which UDF needed to engage an independent auditing firm, particularly in light of the

NASDAQ trading halt, and the critical role that certain FBI-seized accounting and financial

reporting documents played in operating UDF's business and UDF's ability to engage a new independent auditor.

5. Prosecution Team Lead AUSA Bunch initially responded by asking us to prioritize

our requests, purportedly in an effort to expedite the process of locating the needed documents.

After acceding to the demands of Prosecution Team Lead AUSA Bunch to "prioritize our

requests," to view UDF's own business records, months passed with no response and no access

to UDF's documents necessary for running its business and for preparing its periodic financial

reporting and corresponding financial statements.

6. Finally, on June 23, 2016, more than ninety days after our first request and more

than 120 days after the search, UDF's accounting team was granted access to some of the seized

physical documents. Upon reviewing the documents, it was immediately apparent that the

government had made no attempt to inventory, Bates-stamp, copy, or scan any of the seized

physical documents.

7. Attached hereto as Exhibits 1-4 is a series of emails to and from Prosecution Team

Lead AUSA Bunch dated from March 23 to June 21, 2016, communicating our frustration and, at

the time, the inexplicable delay in providing access to the seized documents. I could not reconcile

the government's apparent intent to sabotage and/or interfere with UDF's immediate need for

access to critical company documents necessary to run its business and to prepare financials for an

audit.

8. By May of 2018, more than two years after the execution of the search warrant at

UDF, neither the Prosecution Team nor a Filter Team had returned to UDF originals or copies of

the seized physical materials, despite our persistent demands for copies of the material so that UDF

could meet its business and financial accounting obligations.

- 9. On May 9, 2018, however, Prosecution Team Lead AUSA Nick Bunch, not a Filter Team AUSA, contacted me to request my assistance in segregating privileged from non-privileged materials among a subset of twelve boxes of hard-copy documents allegedly seized from or around UDF attorney Melissa Youngblood's office. The government never explained how, by whom, or pursuant to what criteria these particular boxes of documents had been selected for review.
- 10. I spent approximately two full business days (May 31 and June 12, 2018) at the FBI field office culling privileged materials from these twelve (12) of approximately 750 boxes of documents seized from UDF. The task was complicated by the fact that, despite having held UDF's documents for over two years, the government had not Bates-stamped, scanned, inventoried, logged, or even copied the contents of these twelve boxes, or for that matter, the contents of any of the approximately 750 boxes of physical hard-copy documents seized pursuant to the search warrant.
- 11. The twelve boxes reviewed were non-sequentially numbered: 1B24, 1B28, 1B37, 1B38, 1B51, 1B76, 1B89, 1B181, 1B206, 1B390, 1B423, and 1B734. The contents of the boxes were not otherwise numbered but it appeared that the contents had been previously reviewed, as there were Post-It notes with what appeared to be reviewer's hand-writing on many documents within the boxes. I recall that multiple documents in these boxes were stamped "Attorney-Client Privileged."
- 12. On the first day of our review, we were hosted by a Special Agent who has since transferred to the FBI field office in Knoxville, TN. We were commiserating over the unnecessary time and effort about to be spent reviewing documents that likely never should have been seized in the first place since they were located in an attorney's office. We were also frustrated over the lack of organization and inability to ascertain the documents' origin or subject matter based on the

imprecise and at times seemingly carless manner in which the boxes of seized documents were inventoried, labeled, and/or described. The agent stated to me that he had been taken aback by the overbroad nature of the search warrant, which made it difficult for the agents executing the warrant to determine, with any degree of certainty or particularity, whether a document fell within or outside the scope of the search warrant. He then commented that overbroad search warrants typically result in what happened here—"the agents just take it all."

- 13. After two full days of reviewing the seemingly randomly selected twelve boxes of potentially privileged documents, we had segregated and removed the equivalent of approximately one-and-a-half boxes of obviously privileged materials. Because there were no identifying numbers on the individual pages that we removed as privileged, there was no effective way to document what we had removed. The privileged documents were removed from the original boxes in which they had been placed during the raid, and moved into two (2) new boxes. Those two boxes of privileged material were retained by the government and, I assumed, would ultimately be reviewed under protocols to be approved by the court. Those two boxes of un-Bates numbered private privileged material, to my knowledge, have never been returned to UDF.
- 14. By January of 2019, the government still had not, to my knowledge, either copied or Bates-labeled the physical documents seized from UDF's business premises, despite the fact that we had been requesting copies for years so that UDF could access information necessary for the company's financial accounting and ongoing business operations.
- 15. Nearly three years after executing the UDF search warrant, the government remained inexplicably resistant to working in a meaningful and cooperative manner to provide UDF access to its seized documents. UDF therefore filed a sealed motion pursuant to Federal Rule of Criminal Procedure Rule 41(g) to demand return of at least copies of the approximately seven-

hundred and fifty boxes of physical hard copy documents seized by the government three years prior. It was only after UDF filed that motion that the government began to engage in less combative dialogue with UDF's counsel regarding returning copies of the seized materials.

- 16. It was not until January 26, 2019 that the government finally provided us with a diagram of where the physical documents were seized by the government, and agreed to provide a detailed inventory with particularized locations the following week. *See* Ex. 5.
- 17. The government, however, has yet to return to UDF most of its original hard-copy documents, or even physical copies of hard-copy documents seized during the raid. Instead, the government used a third-party vendor to scan over seven-hundred boxes of hard copy documents and provided UDF's counsel with two hard drives containing PDF images of the seized hard copy documents. These hard drives are essentially useless since the manner in which the documents were scanned lacks any organizational structure, much less a file folder directory.
- 18. On February 25, 2016, we provided Prosecution Team Lead AUSA Bunch with a list of privilege search terms to use in preliminarily identifying potentially privileged materials. At this point, the government had not yet identified a Filter Team Lead. I also had multiple conversations regarding privilege search terms, initially with Filter Team Lead AUSA Jamie Hoxie, and then after she transferred to another office, directly with Prosecution Team Lead AUSA Bunch and various Prosecution Team Agents. Never did a Filter Team AUSA or Agent, or Prosecution Team AUSA Bunch ever state, or even insinuate, that once all seized items were run through the privilege search terms it would be UDF's burden and obligation to provide a privilege log, for an as yet unknown subset of documents, or risk waiving privilege. I always fully expected

¹ In February 2019 Prosecution Team Lead AUSA Bunch identified over one-hundred boxes of hard-copy documents that were seized but apparently not relevant to the government's investigation. Prosecution Team Lead AUSA Bunch allowed UDF to reclaim these documents in February 2019, over three years after the execution of the search warrant.

that once the government ran the seized electronic documents and scanned physical documents

through the search terms, they would seek court approval, or at least UDF's approval, for a protocol

that would be used to review the potentially privileged seized documents.

19. Given the law and lapse in time from the seizure, I can think of no rational reason

(and was offered none by the government) for their failure to (1) seek court approval of a privilege

review protocol that would be used for clearing for prosecution team review potentially privileged

seized documents; (2) return demonstrably privileged documents to UDF and (3) provide Bates-

stamped copies of the seized physical documents to UDF, which the government knew was an

ongoing residential real estate finance business with a portfolio valued in excess of \$1 billion.

I declare under penalty of perjury that the foregoing is true and correct.
